EXTENDED DAY PROGRAM

An extended day program is offered to campers enrolled at Camp Nashoba® Day in the afternoons from 3:30 to 6:00 p.m., Monday through Friday with **exception of July 3rd, 2012, No Extended Day and August 17th, 2012.** Activities offered include the following: snacktime, playground, landsports, singing, storytime, art projects, and more. The rec hall facility is the central location for the extended day program. Counselors range in age between sixteen and twenty five years of age. **The extended day enrollment is limited.**

EXTENDED DAY POLICIES

Extended Day Hours: 3:30 p.m. to 6:00 p.m. Monday through Friday.

Pick-up Time and Place: At or before 6:00 p.m. A late fee of \$5.00 per minute will be charged, beginning at 6:00 p.m. Your child will be released to those people named on the application form. Written permission is required for your child to be released to anyone not listed on the extended day application form. Parents may meet counselors and children at the rec hall, and the adjacent playground.

Parking: Please park in the lot at the bottom of the hill adjacent to the mini golf course.

Speed Limit: Please limit your speed to 7 MPH on the driveway and use extreme caution while driving on the camp road.

Please Note: The main camp office and facility is closed at the end of the regular camp day. If you wish to contact the office, please call during regular business hours between 9:00 a.m. and 3:00 p.m. **Areas not in use by the extended day program are not accessible for visitors.**

Illness: If the camp nurse deems your child is too sick to participate in the extended day, you will be asked to pick-up your child before the end of the regular camp day.

Medical Form: A current physical form and health history is required of all campers and must be received via mail or fax, prior to the beginning of camp and extended day. The Camp Nashoba® Day medical form will be used for the extended day program. Medical forms must be current and must be signed by both parent and physician.

Extended Day Telephone: Please call the office telephone until 2:30 P.M. A message will be relayed to the Extended Day Staff.

A deposit of \$100.00 per child is payable with the Extended Day Application. This amount is credited toward the extended day tuition. No refund will be made for early departures, or absentees. The directors reserve the right to withdraw any camper whose influence or actions are deemed harmful or who will not live within the rules and policies of the camp. If this occurs, no deductions or return of fee, or any part thereof will be made.

The balance of the tuition is due on May 1, 2012. Please make checks payable to “Camp Nashoba® Day”.

A minimum enrollment of eight children in each session of the extended day program is required. If the minimum enrollment is not obtained, deposits will be refunded, and parents will be notified on May 1, 2012, so that alternate childcare plans may be made. Our office will assist you with this change if necessary. **The enrollment is limited to a very small group.**

There will be no extended day on Tuesday, July 3, 2012 and Friday, August 17, 2012.

On the last day of camp the early dismissal time will be the same as the Day Camp. There is No Extended Day on the last day of camp.

EXTENDED DAY POLICIES

Extended Day Hours: 3:30 p.m. to 6:00 p.m. Monday through Friday.

Pick-up Time: At or before 6:00 p.m. A late fee of \$5.00 per minute is payable at the time of pick-up, beginning at 6:00 p.m. Extended Day privilege will be revoked if there is a continuous disregard of the 6:00 pick-up time. **This is enforced.**

Illness: If the camp nurse deems that your child is too sick to participate in the extended day, you will be asked to pick up your child before the end of the regular camp day.

Medical Forms: A current physical form and health history is required of all campers and must be received via mail or fax prior to the beginning of camp. Medical forms must be current and must be signed by both parent and physician.

Extended Day Telephone: Please call the office telephone until 3:00 P.M. A message will be relayed to the Extended Day Staff.

In the event I cannot be reached in an emergency, I hereby give permission to the physician selected by the camp director to secure and administer treatment, including hospitalization for my child as named above.

On the last day of camp, August 17, 2012, the early dismissal time will be the same as the Day Camp.

Your child's enrollment at Camp Nashoba® Day will represent your agreement to your child's participation in the activities of Camp, and acceptance of all benefits and risks of such activities, and I agree to release Camp Nashoba Day, Inc. from all claims resulting from the risks reasonably associated with camp activities.
