Extended Day Tuition: \$250.00 each 2 week session from 3:30 until 6:00 pm. See extended day application form.  
Early morning drop off \$100.00 each 2 week session from 8:00 to 9:00 am.

A deposit of \$500.00 is required with the application. This amount will be credited toward the tuition and will not be subject to refund for absence or change in plans; this non-refundable deposit also applies to siblings. No refunds will be given for late arrival or early departure from camp. The remainder of the tuition for all sessions is due on May 1. The directors reserve the right to withdraw or expel any camper whose influence, conduct or actions are deemed harmful or disruptive to themselves or others, and will not or cannot abide by the rules and policies of camp. If this occurs, no deduction or return of fee, or any part thereof, will be made. Transportation will not be provided if payment is not received. Medical forms must be received by June 1, 2017. There will be a \$100.00 charge for each change of dates, extended day, transportation or grouping after March 1. A fee of \$25.00 will be charged for enrollments received after June 1st. Early enrollment \$200.00 discount on 4 and 8 week sessions until November 1<sup>st</sup> and sibling discounts of 10% on the 2<sup>nd</sup> and 3<sup>rd</sup> children in the same family is offered to campers enrolled in 4 and 8 week sessions.

Tuition includes transportation. There is a designated central pick-up and drop off location for campers who reside in the following towns: Acton, Arlington, Bedford, Belmont, Boxboro, Bolton, Cambridge, Carlisle, Chelmsford, Concord, Groton, Harvard, Lexington, Lincoln, Littleton, Lowell, Pepperell, Stow, Sudbury, Winchester and Westford. A fee of \$100.00 per child will be charged for transportation on 2 different buses or own transportation and bus; own transportation is limited.

Camp is not in session on the July 4<sup>th</sup> holiday and Camp will dismiss at 1:30 on Friday August 18, 2017.

**Riding Lessons:** \$45.00 per lesson. Riding lessons are offered during the eight-week period to campers grade 1 through grade 8. Proper attire is required.
