Riding Lessons: \$100.00 per lesson. Riding lessons are offered to campers one lesson per week. Late enrollment in riding lessons cannot be accommodated. Proper attire is required. Yes enroll in 1 lesson per week \_\_\_\_\_.

Extended Day Tuition: \$400.00 each 2 week session from 3:30 to 5:30 pm. Early morning drop off \$160.00 each 2 week session from 8:00 am. The camp driveway is narrow; speed limit is 10 mph.

A \$500.00 deposit payable by check or visa/mastercard, is required with the application and is not transferable or refundable. A 3% convenience fee is applied to credit card payments. This amount will be credited toward the tuition and will not be subject to refund for absence or change in plans; this non-refundable deposit also applies to siblings. No refunds will be given for late arrival, early departure, withdrawal or dismissal of Camper from camp. The remainder of the tuition for all sessions is due on May 1<sup>st</sup> 2025. Camp is closed on July 4. Camp reserves the right to alter the dates of the camp season.

If camp operations are cancelled before the date scheduled for the start of the camp season (the "Opening Day"), then Parent shall be entitled to a refund of all payments. For purposes of this sub-section, Camp operations may be cancelled in the following circumstances: (i) in the event Camp, in its sole discretion, determines for health or safety reasons that camp operations cannot be safely opened or if (ii) cancellation is required due to circumstances beyond the control of Camp, including without limitation, natural disasters, weather, floods, utility failures, inaccessibility, pandemics, communicable disease (including without limitation COVID-19 or other infectious agent--whether or not the possibility shall be foreseeable), civil unrest, governmental law, order, rule, regulation, mandate, quarantine restrictions, or any similar requirement. Prior to Opening Day, Camp reserves the right to alter the dates of the camp season and in the event such alteration reduces the number of days in the camp season, Camp may make an equitable adjustment (or credit), as determined by it, for payments made.

The directors reserve the right to withdraw or expel any camper whose influence, conduct or actions are deemed harmful or disruptive to themselves or others, and will not or cannot abide by the rules and policies of camp. If this occurs, no deduction or return of fee, or any part thereof, will be made. Transportation will not be provided if payment is not received. Medical forms must be received by June 1, 2025. There will be a \$100.00 charge for each change of dates, transportation or grouping after March 1 payable by credit card. A sibling tuition discount of 5% on the 2<sup>nd</sup> and 3<sup>rd</sup> child in the same family is offered to campers enrolled in the full season.

Bus transportation from Littleton is \$25.00 per week, \$125.00 from Lexington per week and \$100.00 per week for all other towns. There is a designated central pick-up and drop-off location in the following towns: Acton, Bedford, Boxboro, Carlisle, Chelmsford, Concord, Harvard, Lexington, Littleton, Lowell, Stow and Westford. Campers meet the bus at the following locations which is subject to change:

Lexington Harrington School, Bedford Center, Carlisle School, Acton Great Road  
Concord Verrill Farm, Lang & Monument St, Boxboro Town Hall, West Acton Center  
Chelmsford St. Mary's Church, Westford Rodenbush Center, Littleton Center.

I realize that no environment is risk-free, and so I have instructed my child on the importance of abiding by the camp's rules, and my child and I both agree that he or she is familiar with these rules and will follow them. I agree to release Camp Nashoba Day from all claims resulting from the risks reasonably associated with camp activities.
